CONDITIONS OF CERTIFICATION

1. Upholstery cover fabric consisting of exterior type "Harlow PVC synthetic leather" (nominal weight per unit area 200g/m², thickness 0.16mm) followed by type "Harlow PVC foam" (nominal weight per unit area 315g/m², thickness 0.37mm) and type "Harlow polyester textile backing" (nominal weight per unit area 135g/m², thickness 0.57mm). Bonded with PVC adhesive manufactured by Vyva Fabrics and applied in application rate as per fire test specimens.
2. Overall weight 730 +/- 50g/m², thickness 1.20 +/- 0.15mm.
3. All materials, and adhesive, to be of exactly same type as used in original fire test; documentation confirming test type and current manufacturing type and constitutions thereof to be available for verification by audits and inspections by LR and any external authorities.
4. Composition of individual components including any fire retardants to be maintained in production in accordance with originally tested composition formula.
5. Each item, batch or lot of the equipment is to have the "wheelmark" affixed and be issued with a "Declaration of Conformity" affixed after a conformity assessment module is in place.
6. Production items are to be manufactured in accordance with either an approved Production Quality Assurance system (Module D), a Product-Quality assurance system (Module E) or a Product Verification Process (Module F). The Wheelmark cannot be affixed to the product until a conformity assessment module is in place.
7. The certificate holder is solely responsible for the products supplied under this Certificate and to ensure that their products, are fully compliant with the relevant statutory regulations as applicable and are designed, manufactured and installed to the same quality and specifications as the prototype tested, including components that are designed and manufactured by third parties.
8. The manufacturer shall keep a copy of the EC type-examination certificate, its annexes and additions together with the technical documentation at the disposal of the national authorities for at least 10 years after the wheel mark has been affixed on the last product manufactured and in no case for a period shorter than the expected life of the marine equipment concerned.
9. Should a change of Place of Production from that stated below be required i.e. where the stages of manufacture/assembly/testing of this product take place, the new Place of Production is to be advised to us prior to the change taking place. This Certificate will require to be updated for Approval to be maintained.
